Pursuant to Art. 13 of EU Regulation 2016/679 and in relation to the information you will come into possession of, for the purposes of the protection of persons and other subjects about the processing of personal data, we inform you as follows:

1. Objective of Processing

5. Data Controller

At any time you may exercise, pursuant to Articles 15 to 22 of EU Regulation No. 2016/679, the right to:

- (a) request confirmation of the existence or otherwise of your personal data;
- b) obtain information about the purposes of the processing, the categories of personal data, the recipients or categories of recipients to whom the personal data have been or will be communicated and, when possible, the storage period;
- (c) obtain rectification and erasure of data;
- (d) obtain the restriction of processing;
- (e) obtain portability of the data, i.e., receive them from a data controller, in a format that is structured, commonly used and machine-readable format, and transmit them to another data controller processing without hindrance;
- f) object to the processing at any time and in the case of processing for the purpose of direct marketing;
- (g) object to automated decision-making relating to natural persons, including the profiling.
- (h) to request from the data controller access to personal data and the rectification or erasure of personal data same or restriction of the processing concerning him/her or to object to its processing, in addition to the right to data portability;
- (i) withdraw consent at any time without affecting the lawfulness of the processing based on the consent given before the withdrawal;
- (j) to lodge a complaint with a supervisory authority.
